



Highlights:


- On-screen practice is provided showing how to manage files on your diskettes.


To use this course you need:

Using This Course


1. Get out your Private Tutor Presenter/Reporter diskette and slide it into your computer.



If you have two diskette drives, use the one on the left, called drive A, for the Private Tutor Presenter/Reporter diskette, and the one on the right, called drive B, for your Learning DOS 2.00 diskette.


Note: If you have one diskette drive, watch for screen messages that tell you when to switch diskettes.


2. Turn your computer on. If it is already on, do a system reset. That means pressing and holding **Ctrl** **Alt** and then pressing **Del**.



3. Enter date and time, when asked, and press **↵**.
4. When you see **F1Help** displayed at the bottom of the screen, press **F1** for directions about taking this course.


5. When you see this screen, make a note of the serial number displayed. Write it in this space _____.




6. Press  and then follow the directions on the screen. You are on your way to learning DOS 2.00!

Changing Screen Colors

Private Tutor comes with preselected colors. If your computer has a color monitor, you can change the colors when you see **F3 Color** displayed at the bottom of the screen. **F3 Color** is displayed only at the beginning of each lesson. Watch for this screen:

When this screen appears, choose foreground and background colors that provide contrast. For no border, make background and border the same.




Press ← to test your colors.

Use the arrow keys, pictured below, to make your choice.




Turning the Music On or Off

Press **F4** to turn the music on or off.




