Your heart beats with excitement, but steady nerves and exceptional ability keep you ahead of the game. Take a long, non-stop run and kick that ball! Bank it skillfully off a barrier or send it careening off of a border . . . directly past those awesome blue goal posts! How far the ball travels depends upon how far you ran before that mighty kick. There are five chances to score in every stimulating game. At the end, your per-goal average is displayed.

- **LOAD TAPE:** Press SHIFT and RUNSTOP keys. Release RUNSTOP key then release SHIFT KEY. Press PLAY on recorder. Follow instructions in your computer manual.
- **TO PLAY:** Use joystick to move or kick black soccer ball into blue goal post for score. Trick is to bounce the ball off barriers and borders and then into goal. How far ball travels depends upon how long a non-stop run you take before kicking.
- **SCORE:** Kick ball into goal 5 times with least number of kicks for highest score. After 5 goals your average kicks per goals are displayed.

HINT: Avoid kicking square into end of a barrier. The ball will stick there for the length of the kick.
